CORRESPONDENCE:

There was a lot of correspondence received from members of the Town in regards to Bobov Yeshiva. The correspondence from the Gurdijeffe Foundation was read to the board and public.

Many concerns of the public are traffic and buses.

The applicant reviewed the project: The school operates out of Monsey, NY and these are 10 & 11 grade boys who would be attending. There would be no more than 150 students during the summer approximately July and August. The children would be dropped off via bus with the belongings and say approximately 8.5 weeks. The children would be allowed to go home during one Chavez with their parents or by bus. It would be the same boys for the 2 months.

The public hearing was closed during last months meeting and this is not a continuation of the public hearing.

Members of the public (Denise Dunlevy, Star Hess, Jane Nydick, Brian Mendoza, Nora Isenberg, Steve Depinto, Joanne Pentangelo, Steven Barshof, Mark, Brendon Weiden, Brett Wallace, Wanda Gangle, Steve Barshof, Ya El, spoke at the public hearing with their concerns:

Public comments:

- Accessory traffic ~ food, teachers
- Cost town several hundred thousand dollars to redo the shoulder of the road
- No mention of environmental concerns
- Plan does not conform with waste or conserving water
- No special use in town zoning for summer camp
- Already have camps in the town
- Neighbors have to be mailed letters regarding public hearing why do the letters if everyone is against it
- Problem entertaining the camp, indoor /outdoor activities
- Articles were handed out concerning camp on 17B, recordonline dated 7/15/11
- Never seen 100's of people at Gurdijeffe Foundation during the year
- Summer camp not a school increased road use, cause burden on town
- Curious about incident in Monsey with neighborhood complaints, what is the clarity on violations in Monsey
- Memo should be sent out to the town-on-town laws. Can 1 person vote for this to go to ZBA for clarification
- The Town Engineer needs to complete his review of the documents submitted. The planning board is not acting on this tonight. There are many statements asking questions which will be responded to in writing. The Planning Board puts conditions of approval that the applicant needs to live up to. There are problems with the dam that will be addressed by the applicant if approved, nothing will be improved if the application is not approved
- What is the reason why the town decided no more camps previously in the past
- In Brooklyn a school building was built and sold to the public as apartments with no CO which made it no legal for the public to live there. Codes here are different than NYC
- Ruling for Talmud Torah, Warwarsing, for Rabbis and Synagogues.

Public comments closed at 8:24 PM. No further action until the board receives additional documentation for this application.

NEW BUSINESS:

Russell Miller & Jacob Johnson, AMJR, Big Eddy Brewing Co, 93 Main Street, Narrowsburg, NY SBL 10-1-19 for a 10 barrel brewing and restaurant.

Seating for inside according to square footage calculations is 64. Need to condense some equipment to keep people from touching.

The building next door has an access door and a four foot easement between the alley way and 101 Main Street. Jim, the neighbor is concerned about a roof deck being 12 foot from his

living rooms windows. The applicant will be working with the neighbor, there are no plans for a roof deck at this time.

The vault will remain in the building. It might be used as entertainment space or refrigeration. There are two volts in the building, one is with an 8 foot door and the other is smaller.

Brewing will be done on off hours.

The access way on the North side possibly a grab and go from the existing drive-up window, more outdoor eating tables outside. A step would be in the back / fold down ramp to ADA compliant and to move items in and out. There is no food truck as the building would have a permanent kitchen.
